The Age Limit Rule: A Key Factor for Residents

The most important requirement for residents importing a car is the maximum age allowed for registering EURO 6 vehicles. In 2025, the rule is very clear:

You can import and register in Andorra any EURO 6 vehicle that is no more than six years old from its manufacturing date.

A key detail: Andorran authorities consider **only the manufacturing year**, not the month. This means it doesn't matter if the car was made in January or December — the year is what counts.

For example, if we are in November 2025, any car manufactured in 2019 or later can be registered, even if it came out of the factory in January 2019. This flexibility allows many well-maintained vehicles to enter the country without issues.

What Exporting a Car to an EU Country Involves

The export process starts with deregistering the vehicle in Andorra and issuing an export DUA. Once the car arrives in the destination country, an import DUA must be processed, which is the document where VAT is paid and where the homologation and registration procedures begin.

- **Payment of VAT** in the destination country.
